Registration Agreement and Policies for Jansen Dance Project, LLC (JDP) / Collective Soles Arts Group, Inc. (CSAG):

The first installment for Fall/Spring/Summer semester and registration fee are due at the time of enrollment to secure your child's spot in class(es). JDP offers tuition for classes as "Family-Based Tuition"; the tuition amount is based on the total amount of time in classes per week between all family members ages 18 and younger. Costuming Fees vary per child/production. Monthly tuition installments are due on the 1st of each month and may be paid in cash, by check or credit card. All accounts require a credit card to be on file unless ALL tuition fees are paid in full. JDP accepts American Express, Discover, MasterCard and Visa. Fees not paid, will be charged to the card on file. Tuition is due whether a student attends class or not. Classes missed due to a conflict, illness, holidays, vacations, school closings, inclement weather, or any other reason can be made up via Zoom in the same level class or a level lower during the regular season. *There will be no credit for missed classes.* If Hillsborough County schools are closed due to inclement weather or other emergency, then the studio will also be closed, and classes will continue via Zoom. **Termination Policy:** Written or email notice must be given to JDP to officially withdraw from class prior to the first of the month, otherwise, you will be charged for all fees due at that time. Accounts will continue to be billed each month until we have received official notice of withdrawal. **ALL Fees Paid are Non-Refundable.**

****We have taken enhanced health and safety measures. The JDP lobby is now closed to all non-student traffic. All students must wear a mask/face covering upon entry and follow all posted instructions while participating in classes at JDP. An inherent risk of exposure to COVID-19 exists in any public place where people are present. ****

If at any time my child experiences any of these symptoms, I will keep my child home.

* We are following all CDC recommended guidelines as much as possible and limiting our family's exposure to the Coronavirus/COVID-19.

I understand that with any athletic and physical training like what occurs in performing arts classes, there is a risk of physical injury. I do hereby release Jansen Dance Project, LLC (JDP), Collective Soles Arts Group Inc, (CSAG) and any of its staff from any liability, which may occur on or around its premises or at any function sponsored by JDP/CSAG that may occur off premises. I have taken steps to obtain health insurance which will cover any sustained injury. In the event of an emergency, I give JDP/CSAG and its staff the right to obtain medical services for the student(s). I also understand that receiving proper dance, musical theatre and vocal training may involve adjustment of the student's body by the teacher. I understand that this release discharges Jansen Dance Project LLC from any liability or claim that I, my heirs, or any personal representatives may have against the studio with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services provided by Jansen Dance Project LLC. This liability waiver and release extends to the studio together with all owners and employees.
